The West Prairie School District #103 Board of Education met on November 12, 2020, at 7:00 p.m., in a regularly scheduled meeting, at West Prairie High School. Board members present were: Lee Moore, Scott Vogler, Sherrie Weaver, Matt Zimmerman, Lisa Butterfield, and Matt Mencel. Members absent: David Geltmacher.

PLEDGE OF ALLEGIANCE:

The Board and audience stood and recited the Pledge of Allegiance to the Flag.

ANNOUNCEMENTS:

Superintendent Gradert announced November 15th as School Board Members Day recognizing the outstanding efforts of elected school board members throughout the State of Illinois. Lisa Butterfield, Scott Vogler, and Sherrie Weaver were recognized for maintaining their Master Board Member status. Lee Moore and Matt Mencel were recognized as new Master Board Members. Superintendent Gradert announced the district would be taking an adaptive pause and going full remote learning through November 27, 2020. He stated his appreciation of the flexibility, support and cooperation within the organization. Gradert thanked the Colchester Lions Club for the use of tents, tables and chairs and the Colchester Area Gathering Place for the backpack program.

ADMINISTRATIVE REPORTS;

Principal/Athletic Director Caleb Hall announced that Macomb 185 will join the Prairieland Conference beginning the 2021-2022 season.

Principals Cox, Watson, Edholm and Hall all commended their respective staffs for adapting successfully to the adaptive pause.

Superintendent Gradert provided Report Card data for the schools. Three were given the Summative Designation of Commendable while the South Elementary was rated Comprehensive. He announced that the BWP Athletic Cooperative will dissolve at the end of the 2020-2021 sports season. Mr. Hall reassured the players that the sports year would be completed as allowed.
